

conditions of wedding contract

1. The Cradle Boutique Hotel does not accept liability for loss of, or damage to the property or life of the Client.
2. The property is entered into at own risk.
3. No items may be suspended from any structure of the Property, without prior consent of Management.
4. The Cradle Boutique Hotel does not accept liability or responsibility for loss of or damage to any hired items brought onto the Property, or for any goods left at the venue after the function.
5. All hired goods need to be removed by 06H00 (6am) the following day.
6. All accounts are payable as stipulated in this contract, or as otherwise advised by Management.
7. The Client will be charged for any breakages or damage to property caused by the client and/or their guests at the discretion of Management.
8. No items belonging to Cradle Boutique Hotel may be removed from the property without the prior consent of Management.
9. Our Security and Management will deal with inappropriate behavior.
10. Cradle Boutique Hotel reserves the right to deny entrance to the Property.
11. No substances of a Geological or Fauna & Flora nature may be removed from the place where it was found.
12. Venue Hire of the selected venue/venues – pre paid within 14 days of making the booking – non refundable.
13. 50% deposit of total amount, including an estimation of beverages, 6 months prior to the wedding date – non refundable.
14. Full Balance to be paid, 3 months prior to wedding date.
15. Should your wedding be booked for less than 6 months of your wedding date– first month 50% deposit of total amount, including an estimation of beverages to be paid. The remaining 50% amount to be paid in full, 60 days prior to the wedding date.
16. Cancellation of 6 months or more prior to the function – a 50% deposit will be held.
17. Cancellation of less than 6 months – the full estimated amount of your wedding will be held as a cancellation fee.
18. Final guest numbers for functions must be confirmed no later than 2 weeks prior to the date of function, after which, should the numbers decrease, the original amount, will be charged for in full.
- 18.1 Cradle Boutique Hotel waitering staff is employed to be of service for your function. If additional services are required for setup please liaise with management prior to the day concerned.
19. No alcohol, minerals, or perishables may be brought into Cradle Boutique Hotel without prior written consent of Management.
20. No balloons or streamers may be used as decoration on Cradle Boutique Hotel premises. Management should approve all decoration items, which the guests wish to use for their function.
21. No firecrackers are allowed.
22. Management reserves the right to manage audio levels.
23. Only fresh rose-petals or pot-pourri may be used as confetti, i.e. no paper confetti.
24. Only equipments to be allowed in pre-designator areas.
25. Cash bar will be permitted as agreed between the two parties concerned and will have no altercation on the minimum spend for the day.



- 26. All functions that continue after midnight attracts a venue hire of R 2000.00 for the first hour, there after R 3000.00 - The venue closes at 02h00 am.
- 27. A service fee of 12% will be added to the final bill and distributed amongst all staff that contributed their services to your event. This replaces the need for a gratuity and as such need not be the maximum. Guests, at their own discretion, sometimes opt to leave more when the service has been exceptional.
- 28. Please note that a guest list as well as wedding planners list must be provided for entrance into the property, for security measures.
- 29. Guests as well as all suppliers that are driving must present their drivers license at the main gate as proof of identity.
- 30. Any and all persons not in possession of their driver's license/ID will not be allowed access to Cradle Boutique Hotel .
- 31. I, by my signature hereto, agree to bind myself as surety for all amounts that may be due or may become due, owing and payable by the customer to Cradle Boutique Hotel.
- 32. No changes, alterations, variations, or cancellations of any of the above conditions shall be binding on Cradle Boutique Hotel unless agreed there to in writing by Cradle Boutique Hotel.
